

Pursuant to Article 17 paragraph (4) of the Public Procurement Law (Official Gazette of the Republic of Macedonia, no. 136/07) and Article 36 paragraph (2) of the Law on the Government of the Republic of Macedonia (Official Gazette of the Republic of Macedonia, nos. 59/00, 12/03, 55/05, 37/06 and 115/07), the Government of the Republic of Macedonia, on its session held on 26 December 2007, adopted the following

DECREE

on services subject to public service contracts*

Article 1

This Decree shall regulate in more detail the services subject to public service contracts.

Article 2

Services referred to in Article 17 paragraph 1 indent 1 of the Public Procurement Law are the following:

- Maintenance and repair services – Category 1;
- Land transport services, including armoured car services, and courier services, except transport of mail (except rail transport services, covered under Category 18) – Category 2;
- Air transport services of passengers and freight, except transport of mail – Category 3
- Land and air transport services of mail (except rail transport services, covered under Category 18) – Category 4;
- Telecommunications services – Category 5;
- Financial services:
 - Insurance services, and
 - banking and financial services (except services related to publishing, trading and transfer of securities or other financial instruments, brokers' services and services of the National Bank of the Republic of Macedonia, and services the subject of which is purchase or lease of land, buildings or other immovable property and rights resulting therefrom, except in awarding public contracts for financial services related to purchase or lease contracts) - Category 6;
- Information Technology and related services – category 7;
- Research and development services where the results are for use exclusively for execution of the functions and competences of the contracting authority - Category 8;
- Accounting, auditing and bookkeeping services – Category 9;
- Market research and public opinion polling services – Category 10;
- Management consulting services and related services (except arbitration and mediation services) – Category 11;

- Architectural services; engineering services and integrated engineering services; urban planning and landscape engineering services; related scientific and technical consulting services; technical testing and analysis services – Category 12;
- Advertising services – Category 13;
- Building cleaning services and property management services – Category 14;
- Publishing and printing services on a fee or contract basis – Category 15, and
- Sewage and refuse disposal services; sanitation and similar services – Category 16.

Article 3

Services referred to in Article 17 paragraph 1 indent 2 of the Public Procurement Law are the following:

- Hotel and restaurant services – Category 17;
- Rail transport services – Category 18;
- Water transport services – Category 19;
- Supporting and auxiliary transport services – Category 20;
- Legal services – Category 21;
- Services for temporary employment (except services referring to employment contracts) – Category 22;
- Investigation and security services, except armoured car services – Category 23;
- Education and vocational education services – Category 24;
- Health and social services – Category 25;
- Recreational, cultural and sporting services – Category 26, and
- Other services not covered in Article 2 of this Decree (except services referring to purchase, development, production or co-production of programmes by radio or TV broadcasters and for broadcasting period of TV and radio programs) – Category 27.

Article 4

This Regulation shall enter into force the eighth day following the day it is published in the Official Gazette of the Republic of Macedonia.
